Workshop A	Breaking Tradition and Making Learning Fun	William Brunson Joseph Sawyer	Why do most presenters rely on lectures to the exclusion of other learning activities such as small groups, case studies, debates, learning games, etc.? Frankly, because most presenters usually don't know how to teach interactively. Effective courses require presenters to design effective learning activities that help students achieve the learning objectives. During this course, participants will explore a variety of interactive teaching techniques. While learning objectives define what students will learn in a course offering, the learning activities define how the students will achieve those learning objectives. After this fun and engaging session, participants will be able to describe reasons why the lecture method tends to be used to the exclusion of other teaching methods, and summarize how to design interactive learning activities that help their learners accomplish their learning objectives.	
Workshop B	The Art of Facilitation: Guiding Groups in Judicial Branch Education	Jessica Foreman Amber Meyers	Judicial branch educators and meeting planners are frequently tasked with guiding judges, court personnel, and other stakeholders through curriculum planning sessions, committee meetings, and workshops. Great facilitators are not necessarily content experts; instead, they listen and lead groups to find their own answers. Join us for this session on facilitation best practices, Including the facilitation planning process, including needs assessment, room set-up, managing facilitations, and assessing strategies facilitators can use to ensure brainstormed ideas become concrete action plans.	
Workshop C	Sovereign Citizens: How do you educate staff and the Bench?	Jude Del Preore	Sovereign citizen training will equip attendees with the knowledge to recognize and identify sovereign citizens and other anti-government groups and individuals and allow for a better understanding of this subculture. Attendees will learn the history and fundamental principles of the sovereign citizen movement, including their ideological beliefs and doctrines. The course also will strive to teach how to identify possible sovereign citizens through language identification and document recognition. Common criminal tactics, focusing on fraud as it pertains to taxation and property, will be discussed, along with numerous examples of fraudulent documents often used by these individuals to further their criminal goals. Common forms of "paper terrorism" will be discussed along with intimidation tactics often employed by sovereign citizens and how to successfully mitigate them.
