Considering these significant limitations, and with likely expansion of these types laws throughout more of the country, how can we as judicial educators ensure that our judicial officers and court staff will be able access critical instruction that builds our capacity to successfully foster inclusivity and justice for all in our respective court systems? We will discuss some creat solutions for helping maintain widespread access to DEI education for judicial branch employees nationwide.

8:30-9:45 Breakouts: Project Showcase	Option 1: Too Good to Be True—Mandatory Probation Officer Education Refresh in Ohio, Kristopher Steele & Christopher Fields Many new probation officers must complete their mandatory pre-service education before taking cases. Imagine these officers completing the same education in half the time while reducing the days they spend away from the office. Imagine increasing class sizes but also increasing the individual			
	attention each student gets from the faculty. Increasing student satisfaction and increasing the time they spend in role-plays and direct skills practice. Reducing costs dramatically but doubling the number of courses offered each year. Sounds too good to be true - but this is what has happened in Ohio. Come and see how we refreshed a tried-and-true curriculum during 2020. We will not only present data showing improvement in nearly every area you can measure but we will also give you a first-hand student experience during the session.			
	Option 2: Judges & Psychiatrists Leadership Initiative, Jeff Schrade			
	Judges and Psychiatrists Leadership Initiative (JPLI) is a curriculum and program that pairs judges with psychiatrists to train judges about strategies to improve judicial, community, and systemic responses to people with behavioral health needs who are involved in the justice system. The initiative is supported by the NCSC, Council of state governments and the American Psychiatric Association.			
	Option 3: JUSTConnect, An Innovative E-learning Platform, Jacqueline Morris			
	JUSTconnect - an innovative e-learning platform for Judicial Education and collaboration among the Judiciaries in the Caribbean. The platform allows for each country to have their own portal with localised courses, as well as access to a main portal with access to shared courses. Judges can access judicial learning in multiple ways, including self-paced, cohort-based, and other blended forms; and to communicate and collaborate with each other. The pilot phase included 3 countries Barbados, Guyana, and Trinidad and Tobago, and eventually, it will encompass all of the Caribbean Judiciaries, from The Bahamas to Suriname. This presentation will focus on the pilot project, discussing the project, the processes we developed and used, and the results to date, including the IMPACT! on Judges education and regional interaction to date.			
	Option 4: Welcome Aboard! Idaho's New Clerk Online Learning Initiiative, Nick Schulz & Ileen Gerstenberger			
	For years, new court personnel and their supervisors clamored for relevant, just-in-time training for new hires in Idaho. After previous attempts that never gained traction, March 2022 marked the beginning of an initiative that would engage court personnel across the state in meaningful on-demand online new employee education. As time would tell, novice and experienced personnel alike completed courses and grew in their knowledge as a result. This session will cover the organizational and relational factors that lead to the success of this program, as well as the innovative instructional design implemented to engage learners.
